LPN to RN Advanced Placement Option Admission

Thank you for your interest in the New River Community College Associate Degree Nursing (ADN) Program. The Advanced Placement Option (APO) prepares current LPNs for a career as a Registered Nurse (RN). Admission to the ADN program is competitive entry consisting of Test of Essential Academic Skills (TEAS) scores, grade point average (GPA), and ADN pre-requisite courses. Admission and program information is available at www.nr.edu/nursing.

The following requirements must be completed by November 1 prior to the spring semester for which you are applying for admission. Any changes to the application deadline or requirements will be noted on the nursing website. Preference is given to applicants who are residents of NRCC's service region (Floyd, Giles, Montgomery, and Pulaski Counties and the City of Radford).

- _____ Official high school transcript(s) or satisfactory completion of a GED
- _____ Official college transcript(s) if you have attended a college other than NRCC
(Official transcript(s) must show completion of LPN courses with grades of C or higher. If your name has changed, please notify the Nursing Admissions Advisor to help ensure your transcript(s) can be matched to your NRCC records.)
- _____ ENG 111 (English Composition I) with a grade of C or higher
- _____ BIO 141 (Human Anatomy and Physiology I) with a grade of C or higher within the last 10 years
- _____ BIO 142 (Human Anatomy and Physiology II) with a grade of C or higher within the last 10 years
- _____ Mathematics readiness indicated in one of the following ways:
 - College level math course (MTH 154/155 or higher) with a grade of C or higher within two years prior to application deadline
 - MTH 130 (Fundamentals of Reasoning) with a grade of C or higher within two years prior to application deadline
 - MDE 10 with a grade of S
 - Virginia Placement Test (VPT) score demonstrating proficiency on Units 1-5 (the VPT score is valid for one year prior to the November 1 deadline)
- _____ PSY 230 (Developmental Psychology) with a grade of C or higher
- _____ SDV 101 (Orientation to Health Sciences) or SDV 100 (College Success Skills) with a grade of C or higher
- _____ 3-credit Transfer Elective with a grade of C or higher
- _____ Curricular GPA of 2.5 or higher and in good standing with NRCC
- _____ Test of Essential Academic Skills (TEAS) score in the 45th national percentile or higher
(The TEAS assesses knowledge and skills in English, reading comprehension, math, and science. Priority is given to students who receive the highest TEAS scores. TEAS scores are valid for two years.)
- _____ Current professional-level CPR certification (American Red Cross or American Heart Association Basic Life Support – BLS)
- _____ Proof of unrestricted LPN licensure
- _____ Attendance at an ADN general information session
